Informed refusal also depends on the patient's capacity to make sound decisions. A jury would expect you to perform a careful neurologic and psychological assessment. If, based on this assessment, you suspect that the patient isn't capable of making an informed refusal, immediately notify his primary care provider and your nurse-manager.
