Draft Board Resolution for Inter-corporate Loans ...

A resolution is required to officially accept a grant award. Any agency with a board of directors (such as a nonprofit, school district, or hospital) or trustees or any government agency with a decision-making body (such as a city council, town board, or county board of supervisors) needs a resolution to apply for and accept grant funds after an official letter has been received announcing a forthcoming award.

How to Draft a Resolution to Accept a Grant Award - dummies

A Directors' Resolution form is used by the board of directors in a corporation to document decisions and actions (typically) in place of a directors' meeting. Alternatively, a Shareholders' Resolution is used by shareholders in a corporation to propose amendments, decisions, or changes to the corporation at a shareholders' meeting.

Directors' Resolution Form | Free Board Resolution ...

The resolution usually states the action the board is taking and the reasons for that action. Resolutions bring attention to the board's decisions and may be used for publicity reasons or to indicate that the board is complying with the nonprofit's mission.
